BUMA PLANS FOR ROADSHOW FOR ISSUANCE OF NEW BONDS, TENDER OFFER AND CONSENT **SOLICITATION**

Jakarta - PT Delta Dunia Makmur Tbk. (the "Company") herewith announces that its subsidiary, PT Bukit Makmur Mandiri Utama ("BUMA") intends to perform a roadshow in conjunction with the issuance of notes, to several cities in Asia, Europe and the United States commencing on January 22, 2021. BUMA also commenced an offer to purchase for cash its 7.75% Senior Notes due 2022 ("2022 Notes") and a solicitation of consents from holders of the 2022 Notes.

BUMA plans to issue notes outside of the territory of the Republic of Indonesia and in the United States in compliance with Rule 144A and Regulation S under the US Securities Act of 1933, as amended, denominated in United States Dollar at the maximum amount of USD750,000,000 (seven hundred and fifty million US Dollars) and such notes is intended to be listed at the Singapore Exchange Securities Trading Limited ("the New Notes").

BUMA also plans to purchase for cash the 2022 Notes and solicit consents from the 2022 Notes holders to amend the 2022 Notes indenture to align with the New Notes indenture.

In reference with the issuance of the New Notes by BUMA, the Company has obtained an approval from the Company's Shareholders at the Extraordinary General Meeting of Shareholders of the Company on July 9, 2020.

BUMA obtained Ba3 (negative) from Moody's and BB- (negative) from Fitch, and has appointed J.P. Morgan (S.E.A.) Limited and UBS AG Singapore Branch as joint bookrunners and dealer managers.
